- Essay must solely be the original work of the applicants. Plagiarism will result in disqualification.
- Decisions of the judges are final.
- Mentors of The Collegiate Voice and immediate family members are not eligible for this essay contest. Immediate family members of the judges are not eligible for this essay contest.
- The Collegiate Voice will sponsor all passport fees. Receipts will be needed or the contestant will be solely responsible for these fees.
- The Collegiate Voice will sponsor flight, housing, food, and tours. Participant will need their own money for other expenses, i.e. souvenirs.
- Contestant is responsible for their travelers insurance.
- All submissions become property of The Collegiate Voice to use, reproduce, or distribute as it sees fit in its sole discretion, although authorship may be acknowledged.
- By accepting a travel scholarship, winners grant to The Collegiate Voice the right to edit, publish, copy, display and otherwise use their essay in connection with this contest, and to further use their names and biographical information in promotional materials without further compensation or permission, except where prohibited by law.
